#### 1 目的 Purpose

### 2 适用范围 Scope

This policy applies to C&D Inc. and its wholly-owned and holding companies. Each unit may develop corresponding community policies based on its actual situation, which must be consistent with this policy.

### 3 公司责任 Company Responsibility

3.1.1 在业务发展中开展社区风险评估,尽可能地减少对当地社区的负面影响,并将社区发展的优先事项纳入规划考虑,包括但不限于尊重与保护当地社区的原住民权益、文化习俗、文化遗产等。

The company conducts community risk assessments during business development to minimize negative impacts on the local community and incorporate priority issues of community development into planning considerations, including but not limited to respecting and protecting the rights and interests of indigenous people, cultural customs, and cultural heritage of the local community.

3.1.2 由专门的部门负责社区沟通,并接收、反馈重要的社区问题与投诉, 建立互信互利的社区关系。

A dedicated department is responsible for community communication, receiving and addressing important community issues and complaints, and establishing a mutually beneficial and trusted relationship with the community.

3.1.3 通过在当地组织有计划的招聘活动,在力所能及的情况下优先为当地 提供就业机会,在业务发展过程中为当地企业提供合作机会,支持当 地经济发展。

The company organizes planned recruitment activities in the local area and prioritizes providing employment opportunities to the local community to the extent possible. The company creates collaboration opportunities for local enterprises in the process of business development to support local economic growth.

The company strengthens the supervision of local policies and regulations to ensure effective implementation of the policies.
